# AIN-SHAMS UNIVERSITY IN CAIRO (EGYPT) MEDITERRANEA UNIVERSITY OF REGGIO CALABRIA (ITALY) INTERNATIONAL SUMMER SCHOOL

### ART. 1 SCOPE AND GOAL OF THE CALL

The scope of the call is the selection of n. 10 students that will participate to the first edition of the International Summer School #JointLandscapes about #BeniConfiscati with duration of 2 weeks, from 9 to 21 July 2018 in Reggio Calabria and Rosarno (RC).

### ART. 2 PARTICIPATION REQUIREMENTS

The call is open to the students enrolled at university, for the academic year 2017/2018, at:

- III, IV and V year of the Five-year Degree;
- III year of the Three-year Degree
- I and II year of the Degree of Specialization

Following requirements are requested:

- a) Regulated exams;
- b) English language knowledge;
- c) Design and digital modeling software knowledge.

Above mentioned requirements must already be possessed before the deadline of the call for the submission of the applications.

### ART. 3 THE APPLICATION FORM

The application form should be compiled on a normal paper, using the Application Form attached to this call (Attachment A) and signed by the candidate. It should be sent in a closed envelope not later than 1.00 pm on 10/06/2018, to the 'Protocol Office of the Department dArTe — Università *Mediterranea*, Cittadella Universitaria, Salita Melissari - Feo di Vito, 89124 Reggio Calabria.

The following documentation must be attached to the application:

- Portfolio with projects, drawings or sketches realized during the course of study or any other experience, indicating the tools for its realization. The format and the graphics can be freely chosen. The materials should be sent both in hard copy and digitally on DVD;
- Photocopy of a valid identity document.









#### ART. 4

#### SELECTION COMMITTEE, PARTICIPANTS SELECTION, EVALUATION CRITERIA

The assessment of the candidates will be made by a selection committee nominated by the Director of the dArTe Department, and consist of at least 2 professors and 1 technical administrative staff.

The selection of the candidates will be made according to the criteria specified below, through a process that consists of two phases:

- 1. evaluation of the academic career;
- 2. evaluation of the portfolio.

The selection committee can assign to each candidate at maximum 100 points in total, divided as follow:

- max 40 points can be awarded in relation to the exams of the academic career according to the following tabale:

from 18 to 25= 15 points 26/30= 20 points 27/30= 25 points 28/30 = 30 points 29/30 = 35 points 30/30 and 30/30 cum laude = 40 points

- max 60 points can be awarded on the base of the presented portfolio and coherence with the topic of the summer school.

### ART. 5 RANKING OF APPLICATIONS AND ITS PUBLICATION

The list will be compiled as a sum of the first and second phase of the evaluation, and published on the University website by 15/06/2018.

The *Mediterranea* University will promptly communicate the names of the eligible students.

### ART. 6 PARTICIPATION COSTS

The participation cost at the International Summer School is € 200.00 (two hundred); the first five ranked students will be exempted from payment. The University reserves the right to increase the number of exemptions compatibly with any additional available resources. The costs include round trip from Reggio Calabria and Rosarno (RC) and the meals organized during the second week of the summer school, as well as the expenses related to the teaching material. The payment of the registration fee should be made within the first week after the announcement of the winning students on the following bank account IBAN IT59U0200816303000102461202 - BIC / SWIFT UNCRITM1585, causal payment: Participation at the International Summer School #JointLandscapes about the #BeniConfiscati.









# ART. 7 PARTICIPATION CERTIFICATES AND CFU RECOGNITION

The students attending the International Summer School will be awarded of a participation certificate, issued by the *Mediterranea* University of Reggio Calabria.

To their students attending the International Summer School *Mediterranea* University of Reggio Calabria at the end of the workshop will recognize **n. 6 CFUs** of type F.
